3. Upcoming Changes and Noteworthy Details

- The next TTI conference call is scheduled for 18 September 2019. A review of Georgia's crisis bed system will be given. This will be an excellent opportunity to learn more about the TTI effort and the changes that will be coming to the Acute Care Service Utilization database. This initiative is a Federally funded project aimed at improving bed utilization data. - Discussion has been ongoing since enhancements 8378, 9477, 9605, and 10033 were identified
 as having significant impact on Submitting Entities. Final decision has yet to be made as of this
