3. Upcoming Changes and Noteworthy Details

- The team has designed a solution that satisfies the business requirement to grant MEs direct
 access to all the data they've submitted into FASAMS. This solution is scheduled to be complete
 by September. However, to make data accessible earlier; the team is testing an interim solution
 that should enable MEs to extract their data via SSRS.
- The Enhancements for Q1 FY2019 2020 are being defined and prioritized over the next several weeks.
