

1. Activities Completed During the Week Ending 5/3/2019

- Continuing to work with AHCA on a new Data Sharing Agreement (DSA) required for Medicaid encounter data, the draft agreement is currently in review at DCF. The final version is being reviewed by our Security Manager before it's routed to our CIO for her signature.

3. Upcoming Changes and Noteworthy Details

- Ticket 8713 for Monthly Extract of Successfully Submitted Managing Entity Data was scheduled for the Q4 Release; it is being expedited as an exceptional release but must go through DCF's budget approval process first. The approval is in progress now.
- The requirement for enhancements for Q4 FY2018- 2019 will continue to be gathered over the next several weeks, please note the enhancements for the Q4 release are still being reviewed and are not final. The current list of approved enhancements is available in section 8 Q4 Enhancements below.
- Preliminary plans for moving TANF, SANDR, and DOC into FASAMS are in progress with DCF staff. DCF plans to have a transition plan in place by June 30, 2019.
- There is a change to the monthly maintenance window for the month of May. The third Saturday will the 18th of May. The monthly maintenance will be performed on Sunday, May 19, 2019 from 6 a.m. – 10 a.m.
- The FASAMS Support Team has started to transition their assignments to DCF staff and will complete transition by June 30, 2019.
- The FASAMS Assessment Team will be conducting site visits with some MEs.
