

#### 1. Activities Completed During the Week Ending 3/8/2019

- DCF rolled out one new hot fix this week with release 1.0.6 (See FASAMS Release Summary below).
- One new enhancement was submitted to FEI for evaluation this week. The enhancement request
  would add functionality to the system that would automatically notify users by email 5 days in
  advance of their password requiring a change. This is required every 45 days. In addition, a 5day email notification would be sent ahead of inactivity durations of 45 and 60 days. Currently
  user accounts are locked if there is no activity after 45 days, and their accounts are disabled after
  60 days.
- Continuing to work with AHCA on a new Data Sharing Agreement required for Medicaid encounter data, the agreement is in review with Senior Management at AHCA.
- Hotfix 1.0.6 was deployed by FEI and tested by DCF, and the following defects were addressed:
  - o 8663 Submission: Unexpected Error on FASAMS production
  - 8670 Contract Compliance reports. The blue background of each report title is long, and it prints an extra piece on the second page
  - 8686 Administration: Error Messages in UAT with User Account Administrator Role
  - o 8712 All Reports have Headers Repeat

#### 2. Activities Planned for the Week Ending 3/15/2019

- Review all the report changes that have been made with the recent hotfixes.
- Conduct JAD sessions scheduled with FEI and DCF for 3/5/2019 and 3/7/2019.
- Continue to work on the MCI/MDM interface issues for FASAMS, the next meeting is scheduled for 2/29/2019 with the MCI/MDM teams.
- Continue work on the new incident management process.
- Work on Change Management Policy to address new or old OCAs

#### 3. Upcoming Changes and Noteworthy Details

- The incident management process will be revamped so that Tier 1 support will eventually come
  through the DCF help desk. Planned rollout is March 18th. <u>Please note</u>: Once this change is in
  place all service requests should be submitted to the DCF Help Desk and FASAMS users will no
  longer contact the vendor directly.
- Enhancements for Q4FY2018–2019 will be gathered over the next several weeks, and enhancements for Q1 FY2019-2020 will also start to make it into the long-range enhancement plan. Please note the enhancements for theQ4 release are still being reviewed and are not final.
- FEI will address several reports that are running much slower than is expected. FEI will work over the next several weeks to increase the performance of the reports.
- The FASAMS Support Team continues to validate the accuracy of data in various FASAMS reports and to identify issues that need to be fixed (e.g., calculation of units and amounts contracted versus units and amounts earned for various projects.)
