	date.
	The "Ages 6 to 12" tab provides summary counts and percentages of children, ages 6 to 12, by their type of out-of-home placement and whether or not they have an active psychotropic medication as of the report run
	date.
	The "Ages 13 to 17" tab provides summary counts and percentages of children, ages 13 to 17, by their type of out-of-home placement and whether or not they have an active psychotropic medication as of the report run

	Placement Setting Descriptions: A relative/non-relative placement includes children placed with relatives or approved family friends. Licensed Substitute Care includes children placed in licensed foster care, group
