| | Placement Setting Descriptions: A relative/non-relative placement includes children placed with relatives or approved family friends. The Other placement setting includes children who are missing (runaway/absconded/abducted), in a hospital, correctional placement, or other placement settings not included above. Children who are in the process of changing placements (i.e., a placement had been ended and new one has not yet been entered into FSFN) or whose placement information has otherwsie not yet been entered into FSFN are counted in the "Placement Data Not Available" columns. |

If all medications have consent properly documented and all such consents are Court Order Obtained, the child is counted in the Court Order counts. Proper documentation includes either Parental Consent or Court Order Obtained and the date such consent was obtained both being documented in FSFN. Any consent dates that are after the run date of the report or which are entered after the report run date are not considered valid for these puproses.
