Report Description

Purpose:	This report provides information on children in out-of-home care and the number and percent who have a psychotropic medication prescribed.
	All children in an active out-of-home care placement as of the report date are included in the report. In addition, children who are an active participant in a case with a service role of child or blank who are in a removal
	episode that has not yet been discharged but their last placement has been end-dated are also included in the report.
Criteria:	
	A psychotropic medication is any medication selected from the medication drop-down list (excluding "Other") on the FSFN medications screen or if "Other" is selected and the medication is flagged as a Psychotropic
	Medication or as being used for psychotherpeutic purposes.

	date.

	The "Ages 6 to 12" tab provides summary counts and percentages of children, ages 6 to 12, by their type of out-of-home placement and whether or not they have an active psychotropic medication as of the report run
	date.
