Report Description

Purpose:	This report provides information on children in out-of-home care and the number and percent who have a psychotropic medication prescribed.
	All children in an active out-of-home care placement as of the report date are included in the report. In addition, children who are an active participant in a case with a service role of child or blank who are in a removal
	episode that has not yet been discharged but their last placement has been end-dated are also included in the report.
Criteria:	
	A psychotropic medication is any medication selected from the medication drop-down list (excluding "Other") on the FSFN medications screen or if "Other" is selected and the medication is flagged as a Psychotropic
	Medication or as being used for psychotherpeutic purposes.

	date.
	The "Ages 0 to 5" tab provides summary counts and percentages of children, ages 0 to 5, by their type of out-of-home placement and whether or not they have an active psychotropic medication as of the report run
	date.
	The "Ages 6 to 12" tab provides summary counts and percentages of children, ages 6 to 12, by their type of out-of-home placement and whether or not they have an active psychotropic medication as of the report run
	date.

	above. Children who are in the process of changing placements (i.e., a placement had been ended and new one has not yet been entered into FSFN) or whose placement information has otherwsie not yet been entered
	into FSFN are counted in the "Placement Data Not Available" columns.
