In accordance with the authority vested in the Chief Judge by Rule 2.050 of the Florida Rules of Judicial Administration, and pursuant to the Supreme Court of Florida's mandate to establish a Family Court Division, it is

ORDERED that:

Effective October 1, 1992, a Family Court Division was established.

1. JURISDICTION.

The jurisdiction of the Unified Family Court shall include the following:

2. Dependency actions, termination of parental rights and delinquency actions shall be deemed part of Unified Family Court, although the Clerk's computer filing system remains separate at this time.

3. The above categories of cases (marked with *), as well as ex-parte pick-up orders of minor child(ren), will require the clerk to search both the domestic relations and dependency filing system to determine if there is a (crossover) or related case so that the case is properly assigned.

4. Any day to day clarification or disputes concerning proper filing or assignment may be made by the Administrative Judge of the Unified Family Court.

5. This order rescinds and replaces Administrative Order II-92-F-3A.

6. Unless otherwise indicated above, this order takes effect upon the date signed.
