- OITS, SAMH, and LSF staff completed the first planning meeting to outline the purpose and scope of the data submission pilot. The purpose of the pilot is to guide one or more service providers, an EHR provider, and one ME through the entire data submission process so that we can capture lessons learned (operational and technical) that will help us improve the system and share insights with other FASAMS stakeholders.
